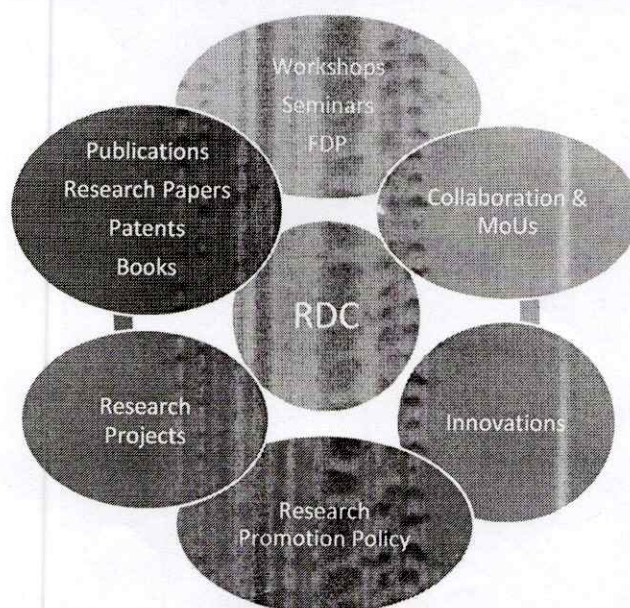

2. CONSTITUTION OF RESEARCH DEVELOPMENT CELL (RDC)

- 4.4 To organize refresher courses, research-oriented training programs and workshops.
- 4.5 Organize national and international conferences and seminars.
- 4.6 Organize paper presentation competitions to instil the concept of research in faculty and students.
- 4.7 Organize guest lecturers under Institute-Industry-Interaction programs to promote research on industry needs.
- 4.8 Development of infrastructure conducive to promoting the quality and quantity of research and development.
- 4.9 Promote the number of collaborative activities with other institutions/research establishment/industry for research and academic development of faculty and students.
- 4.10 Promote number of functional MoUs with institutions/ industries at both local and international level.
- 4.11 Promote the number of extension and outreach programs.
- 4.12 Promote the policy on consultancy including revenue sharing between the institution and the individual.
- 4.13 Motivate all faculty members to pursue research in their respective areas of expertise.
- 4.14 Motivate the faculty members to do consultancy work and encourage them to file patents.
- 4.15 To foster the development of multi-disciplinary research endeavors across faculty members and departments.
- 4.16 Monitor the research and development performance of individuals and groups to encourage excellence and productivity by maintaining a database of research and development activities.
- 4.17 Promote the publication of research papers in indexed journals, number of books and chapters in edited volumes and filing of patents.
- 4.18 To monitor entire quality and research integrity of PhD Programme.

Research Development Cell members are expected to report the research activities of their department/school in a meeting which will be held at least two times in a year. Proper feedback on the functioning of the cell from the faculties and students will be collected for
