(57) Abstract :

The present invention relates to the preparation of cost- effective poly herbal formulation and evaluation of its anti-oxidant activity. Poly herbal formulation comprising the components of Acacia Arabica Gum, Stems of Agrimonia Eupatoria, Bulb of Allium Cepa and Allium Sativum, Dried Leafy Juice of Aloe Vera, Nuts of Areca Catechu, Leaves of Azadirachta Indica, Camellia Sinensis, Eucalyptus Globules, Mangifera Indica, Murraya Koenigii, Ocimum Sanctum, and Stevia Rebaudiana. Roots of Boerhavia Diffusa, Glycyrrhiza Glabra, Fruits of Emblica Officinalis, Syzygium Cumini, Foeniculum Vulgare and Elettaria Cardamomum. Unripen Fruits of Musa Acuminate, Solanum Lycopersicum, and Aerial Parts of Swertia Chirayita. Wherein the prepared poly herbal formulation were formulated into any one of granules, fine powders, tablets, and capsules. The Prepared Poly herbal formulation is safe to use and free of side effects and toxicity.
