

6. Programme Ordinance

1. Title & Commencement

- The Ordinance shall be called as Ordinance for Two years (Four Semesters) LL.M. Degree course.
- This ordinance will come into force from the Academic Session commencing after the date of notification issued by the university and shall replace the existing ordinance.

2. Duration:

- The duration of LL.M. degree course shall be of four semesters (Two Academic Years). The maximum duration for completing the course shall be of four consecutive academic years. If a student is unable to clear all the semesters of the program within the maximum duration (as specified above), he/she will automatically exit from the program.
- The maximum total duration shall include the period of absence, withdrawn and different kinds of leave permissible to a student but it shall exclude the period of restication/suspension/or any other penalty period imposed by the University.
- 3. The student after successful completion of the four semesters of the programme shall be awarded LL.M. degree for which he/she was enrolled.

3. Number of Seats

Number of seats in this course will be as approved by UGC and notified by the Academic Council of the University and as advertised for admission to the course.

4. Eligibility for Admission:

1. Admission to this course shall be made through direct/ entrance examination as notified by the university from time to time.

Registrar IFTM University Moradabad. To be eligible to appear for admission to two year- LL.M. Programme, a candidate should have passed the LL.B or an equivalent degree from a recognised University with not less than 45% marks in aggregate (40% in case of reserved categories, i.e. SC/ST/Persons with Disability).

5. Attendance & Eligibility for The Examination

Every student shall have to secure minimum 75% attendance in the course concerned for appearing in the end semester examination. However, if any student fall short of 75% attendance in a particular paper the Dean of the School concerned can permit him for appear in the end semester examination provided the student has secure 75% or more attendance in all other papers of the course in the given semester.

6. Medium of Instruction

The medium of instructions in general shall be English or Hindi except for language courses and the medium of examination in general shall be English/Hindi except language courses. However, university may notify the medium of instruction for a specific programme, and in such cases the medium of instruction shall be as notified by the university.

7. Examination & Evaluation

- The academic performance of a candidate shall be evaluated in respect of the courses of study prescribed for each semester through the evaluation. The evaluation of students admitted in any of these Programmes shall be based on End Semester Examinations, and Continuous Internal Assessment.
- 2. Out of the total marks (100 marks), 70% shall be allotted for the end semester examinations and 30% shall be allotted to continuous internal assessments during the semester. The scheme of internal assessment shall be as: There will be two compulsory internal exams of 10 marks each and 5 marks for Assignment and 5 marks for Attendance. If a student fails to give internal exam because of some emergencies / unforeseen situations, the Dean of the School may permit the student to appear in the special internal exam on the satisfaction of the reason mentioned by the student for not appearing in the regular internal exam.
- External Question Paper shall contain Ten Long Questions. Students have to attempt any five questions out of Ten long questions. All long questions shall carry equal marks (i.e.14 marks/ question) & there shall be at least two questions from each unit.

- 4. To qualify the course, a student should required to secure minimum 35% marks in individual paper and minimum of 45% marks in aggregate including the Sessional and External Examination and minimum 50% marks should secure in Practical/ Viva- Voce/ Project Work.
- 5. The minimum Grade required to pass in each Theory & Practical paper is 'GRADE D'.
- 6. A candidate who secures less than 45% (4.50 CGPA) marks in a course shall be deemed to have failed in that course. In case a student has secured more than 35% marks in a semester, but obtained less than 45% marks in a semester, he/she shall reappear in the course to achieve the required aggregate percentage (of 45%) in the semester.
- 7. Maximum numbers of Carryover paper permissible for promotion to next academic year are 04 theory / practical / project papers.
- 8. The end semester examinations will be held on such dates as may be notified by the appropriate authority of the University.

8. Elective Based System (EBS)

Elective based system (EBS), provides a learning platform wherein the student or knowledge seeker has the flexibility to choose their course from a list of elective course. This is a student-centric approach to achieve his target number of credits as specified by the UGC and adopted by our university

Guidelines:

- 1. In the beginning of the semester every student of LL.M. will be given a topic related with the Indian legal system for preparing a Dissertation. A faculty to act as supervisor would be assigned to the student by the Director/ Principal/Head of Department.
- 2. Students will have to complete the Dissertation within 3 Months. For this work no exemption from attending the regular classes will be given to any student.
- 3. The student after completing Dissertation will submit it to the college, which will form part of the semester examination.
- 4. The dissertation prepared by the student will be titled as research work. The dissertation should be based on primary data. It should reflect in depth study of a legal problem, ordinarily assigned by the Director/ Principal of the College. Relevant case laws, amendments, bibliography should support it with foot noting.
- 5. The dissertation should be divided into chapters. The first Chapter should deal with the brief information of Indian legal system and its challenges. The other chapters will contain the research work on the given legal problem. The average size of report will be ordinarily 150-200 typed pages in Times New Roman font with standard font size (12) and double spacing. Two neatly typed and soft bound (paperback) copies of the report will be submitted to the college. The report will be typed on A4 size paper.
- 6. A certificate issued by the supervisor for coordinating the research work under his/her guidance should be attached with the dissertation.
- 7. The dissertation will be evaluated by internal & external examiners. Internal evaluation would be done will be done by a committee of three members including the faculty who supervised the project and other two nominated by the Director/ Principal. External evaluation will be done by the examiner(s) appointed by the examination division of the University. Evaluation scheme shall be as follows:

Internal (100) on the basis of quality of the contents & presentation followed by questions asked. External (200) on the basis of quality of the contents & presentation followed by questions asked.

 - a. Cover page
 - b. Preface
 - c. Acknowledgement
 - d. Index
 - e. Objective of the project work undertaken
 - f. Literature Review
 - g. Project / Research Methodology
 - h. Results and Analysis
 - i. Conclusions
 - j. References
 - k. Appendices to include Questionnaire, if any.
