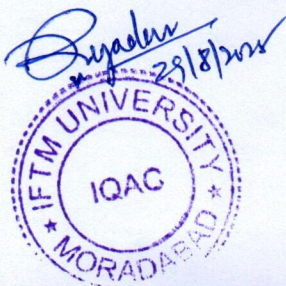

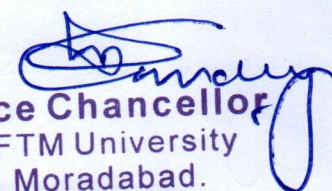
IQAC- XXXVI (07): To discuss and ensure the organization of regular industrial visits for students of all programmes.

The Registrar added that these visits bridge the gap between theoretical classroom learning and practical applications, motivating students and shaping them into well rounded professionals.

IQAC- XXXVI (09): To discuss the Academic Calendar for the Session 2025-26.

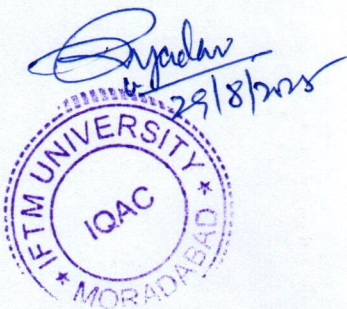
